② Meera Kaul had always spoken with a threatening tone ever since she moved into my condo. She and her partners would threaten me by saying 'you are a path and you are harassing us by asking for your rent, we will sue you and get all of our money back.' After which I had been too scared to even send rent reminders when Meera Kaul stopped paying rent at all.

③ After I started eviction process due to nonpayment of rent, Meera Kaul mailed me a Demand for Payment letter accusing me of owing her money with all false claims about me harassing her, when I did not even attempt to contact her at all. Meera Kaul's mails/emails cause so much emotional distress in me that I got a fever and cold for days and couldn't concentrate on work/family life for weeks due to fear of her and her partners in crime.
